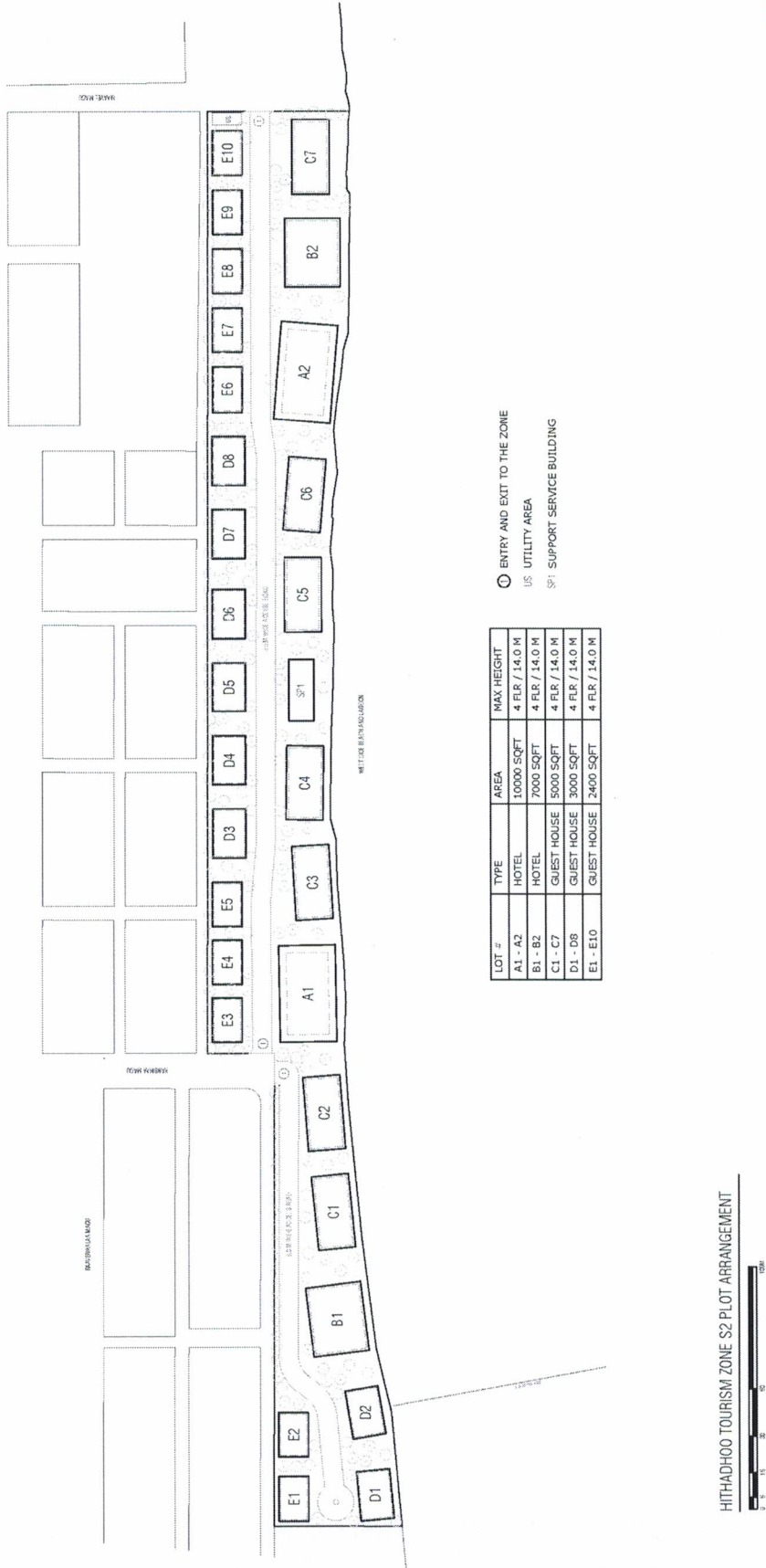

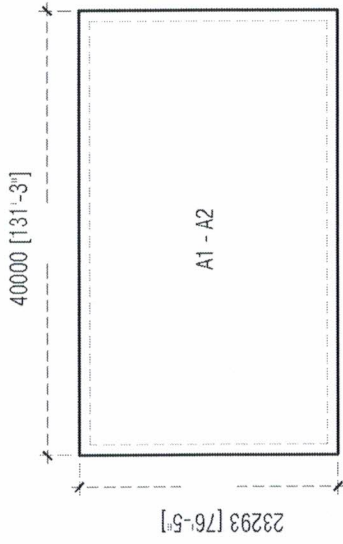

Map of the Land allotted in Hithadhoo as Hithadhoo Tourism Zone (S2)

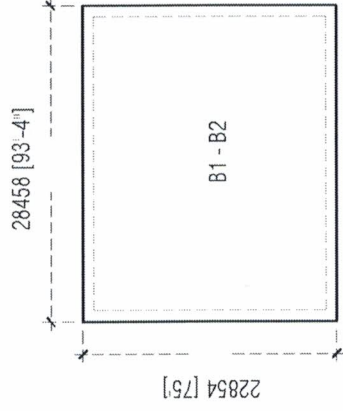


HITHADHOO TOURISM ZONE S2 PLOT ARRANGEMENT

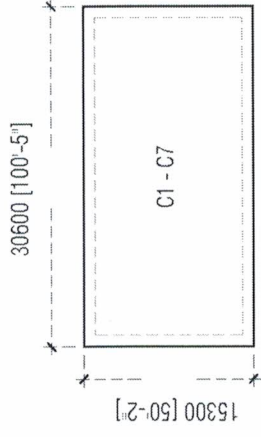




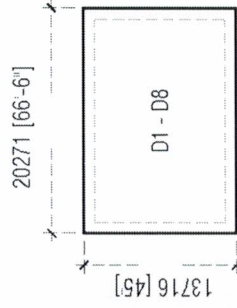

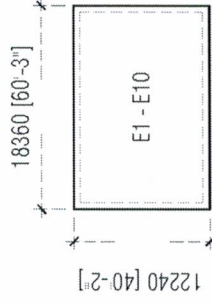

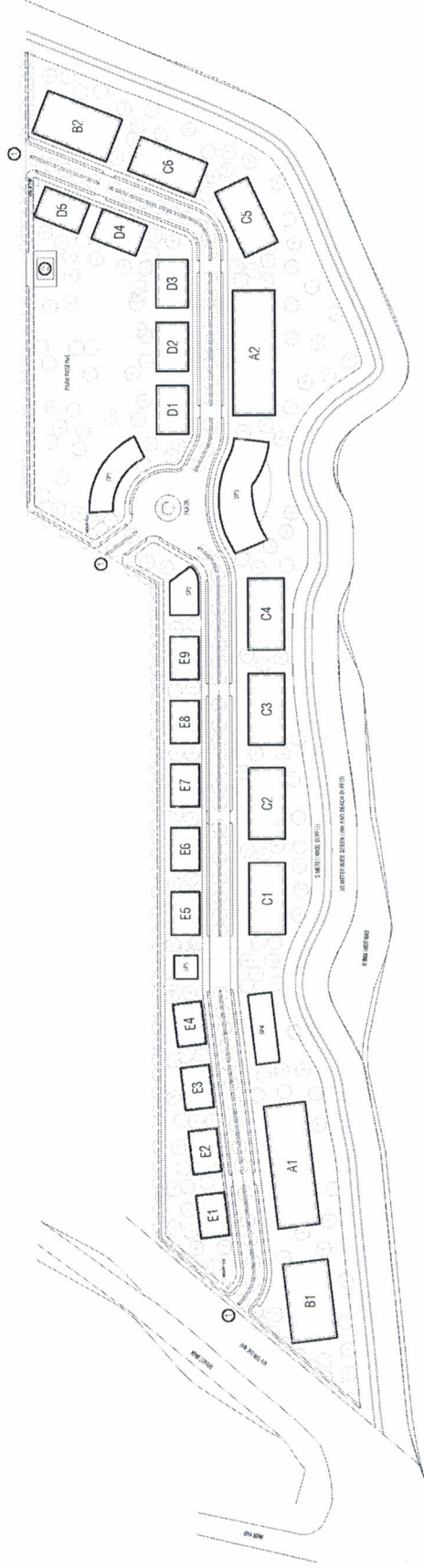

Map of the Land allotted in Feydhoo as Dhigihere Tourism Zone (S4)

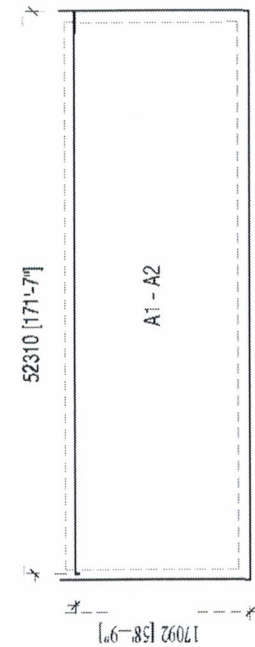

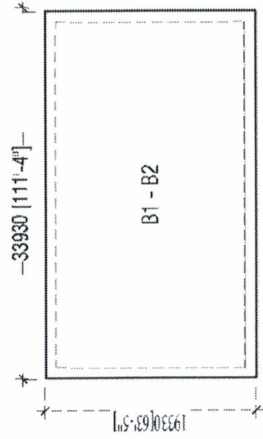

FEYDHOO TOURISM ZONE S4 PLOT ARRANGEMENT

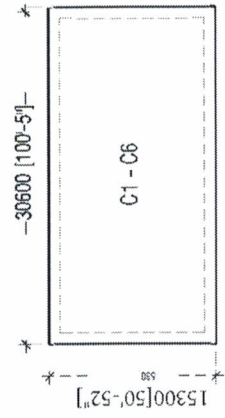




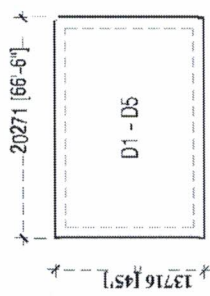

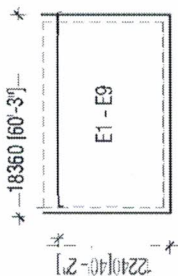

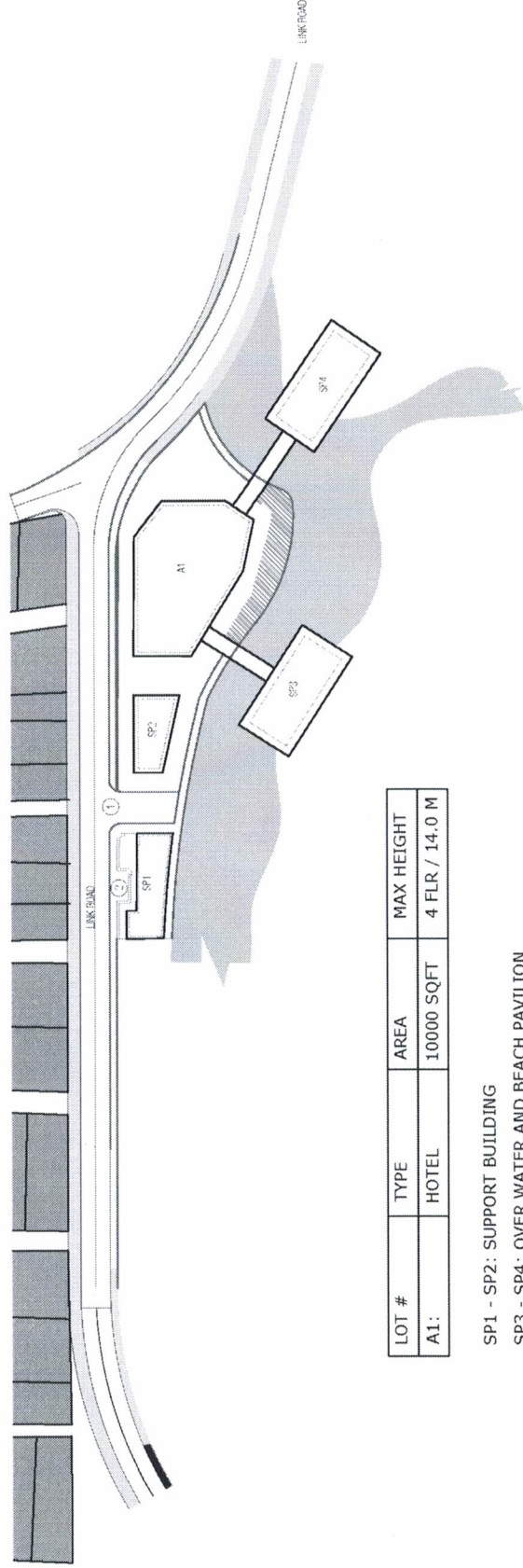

Map of the Land allotted in Maradhoo as Venbolhafishi Tourism Zone (S3)

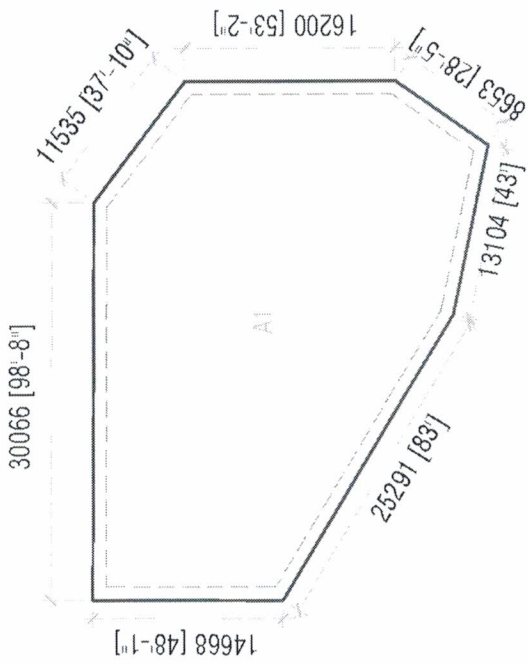

MARADHOO TOURISM ZONE S3 PLOT ARRANGEMENT





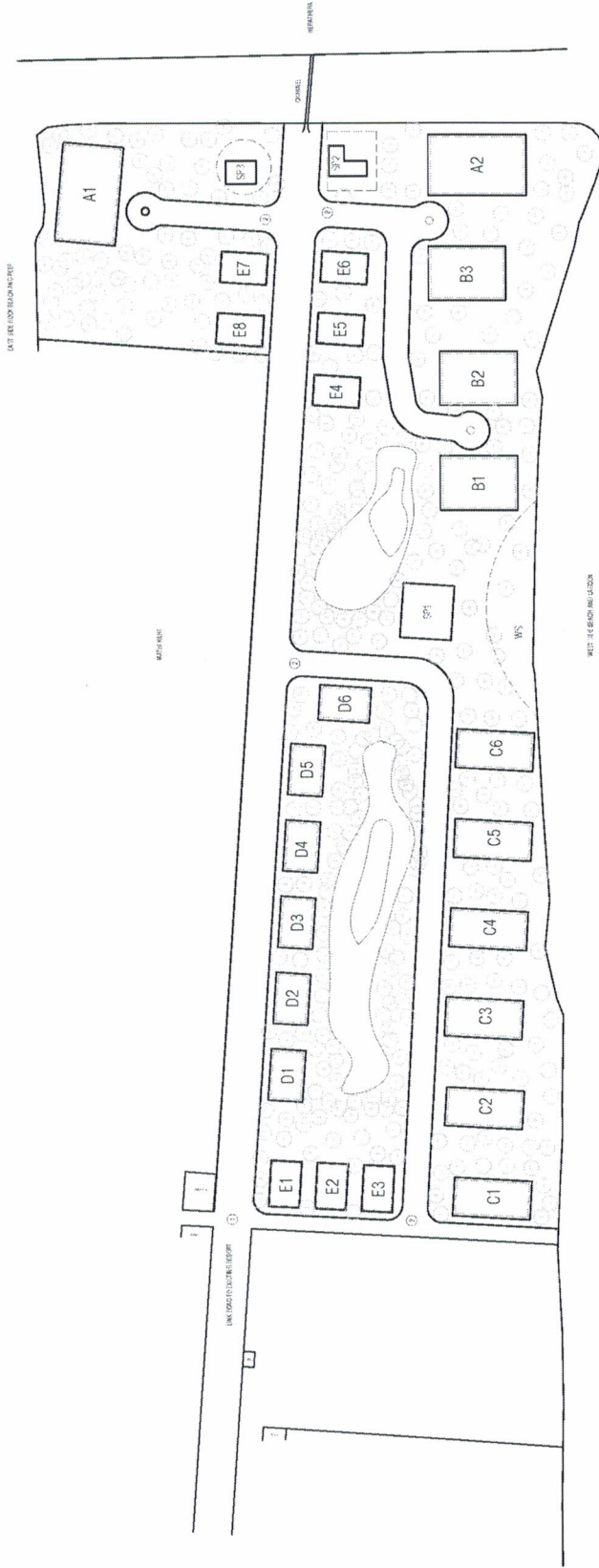

Map of the Land allotted in Hulhudhoo as Maafishi Tourism Zone (S6)

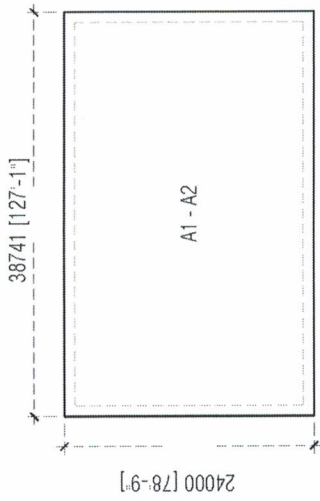

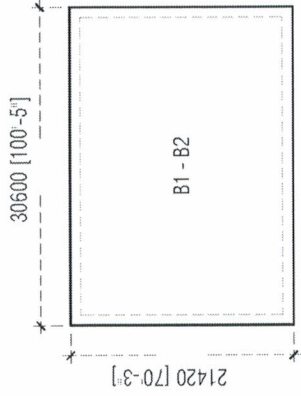

HULHUDHOO TOURISM ZONE S6 PLOT ARRANGEMENT

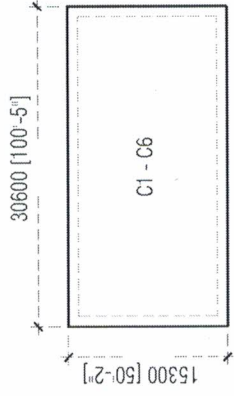




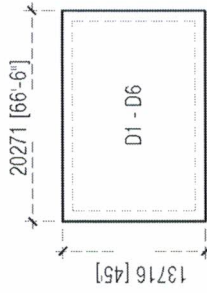

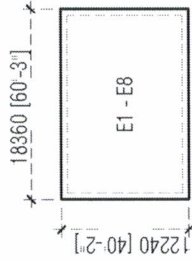

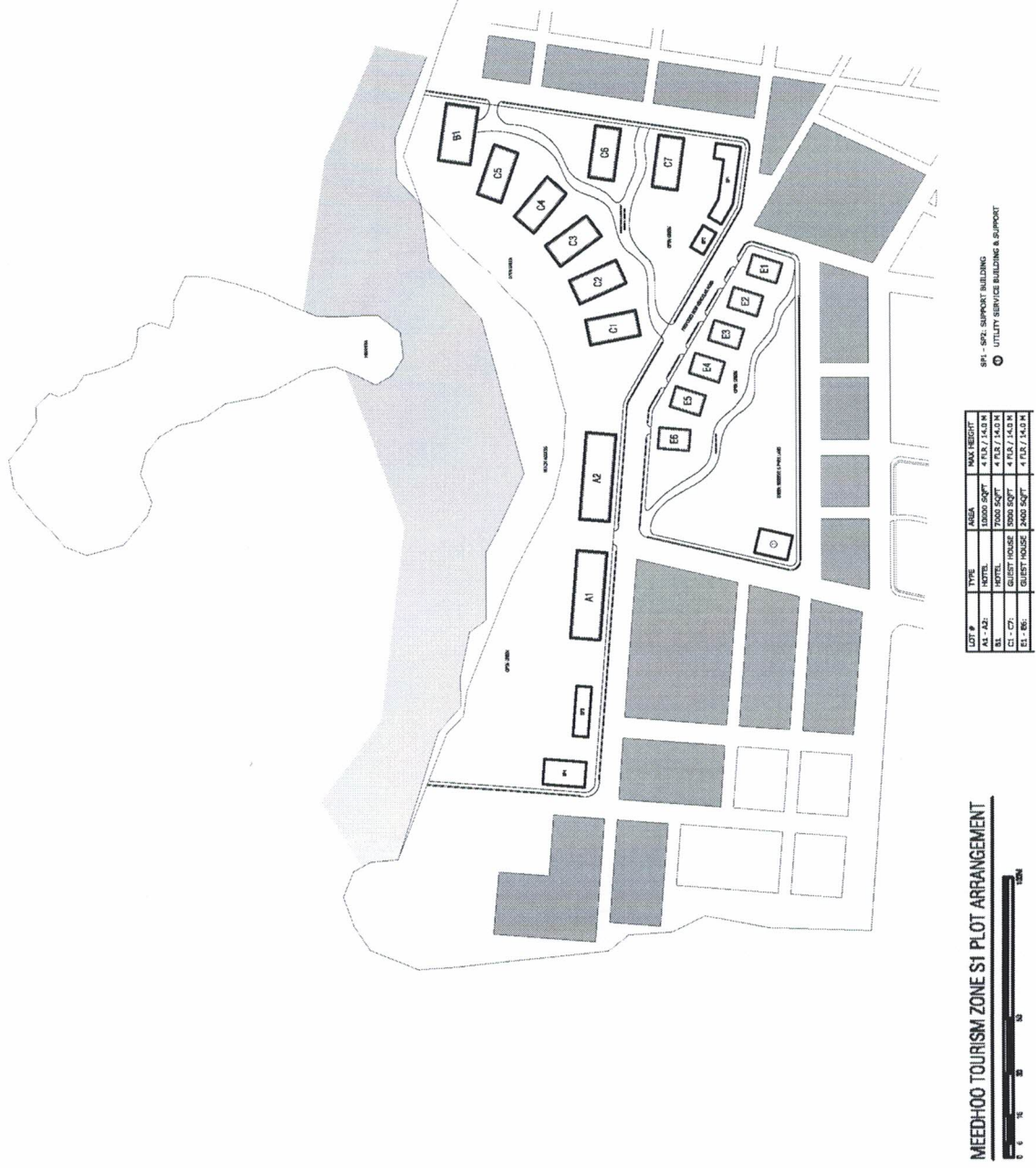

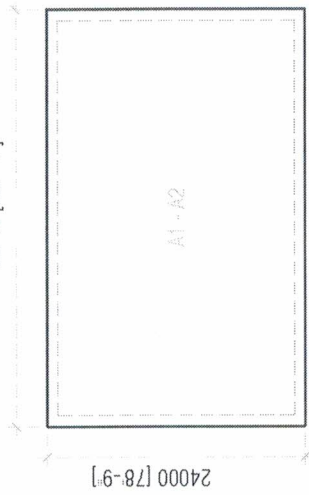

Map of the Land allotted in Meedhoo as Mulimathi Tourism Zone (S1)

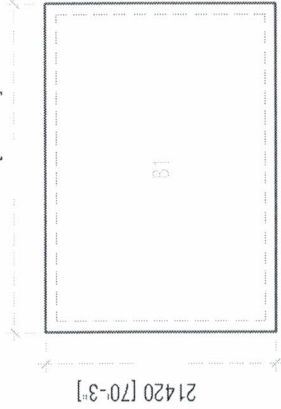

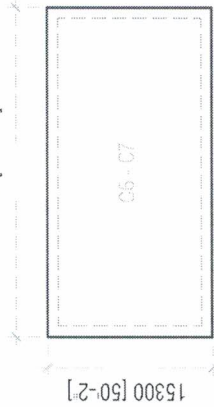

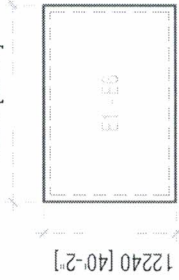
